# **HOW TO APPLY FOR PERMANENT RESIDENCY?**

To apply for the Greek Golden Visa, non-EU citizens who purchase property in Greece can apply for a residence permit to live in Greece for 5 years.

#### IS THERE A MINIMUM AMOUNT THAT YOU **HAVE TO PURCHASE A PROPERTY FOR?** When purchasing property under the Greek Investment residency programme,

the value of the property must be EUR 250,000 or higher.

## Apply for a Greek Passport (EU) in 7 years after obtaining Greek PR status. You need to live in Greece for a minimum of 180 days a year.

#### With a Greek residency permit, travel freely across the Schengen zone - 26 European countries without visas or border controls. The Golden Visa eliminates the need for additional visas during your travels.
