

PORTUGUESE GOLDEN VISA

What is the Portuguese Golden Visa?

The Portugal Golden Visa scheme allows investors and their families to reside in Portugal, in exchange for a qualifying investment.

How to apply for the Portuguese Golden Visa

You can apply for the Golden Visa by:

- Donating **€250,000** to the arts
- Establishing a venture capital/private equity fund of €500,000
- Donating €500,000 to research activities
- Creating a company with 10 employees or €500,000 + 5 employees

All candidates must make a qualified investment and maintain it for 5 years.

What are the requirements for a residency application?

Any non-EU/EEA/Swiss national can apply for the Portuguese Golden Visa.

Applicants must be **over 18** and have no criminal record. Investment funds must arrive from outside of Portugal.

Does the Portuguese Golden Visa apply to family?


The Portuguese Golden Visa can be extended to the main applicant's **spouse** and financially dependent **children** (provided they are full-time students and unmarried) as well as their **parents** (over 65 years of age).

What are the application steps?

- 1 Choose the investment type.
- 2 Gather all necessary **documents** for yourself, the main applicant, as well as all those for dependents.
- 3 Get the NIF (Portuguese fiscal number) and open a bank account in Portugal.
- **Finalise** the investment.
- Submit the **pre-application** online to Agência para a Integração Migrações e Asilo (AIMA).
- 6 Schedule your AIMA appointment.

How long does residency take once the application is complete?

The initial application and the supporting documents are submitted online AIMA. Once approved, you need to appear for an in-person interview at any AIMA office. It can take up to **six months** for AIMA to approve and provide a biometrics appointment date.

How long is the residency permit valid for? Your residency permit is valid for 24 months after which it

can be renewed for a further 36 months.

Are there any requirements in terms of language?

In Portugal, you have a basic IRS (personal taxation) based

How is personal tax calculated?

in your income, ranging from 13 to 48%.

How is company tax calculated? Company tax (IRC) is applied on fiscal profits: for Portugal

mainland 21%, for Madeira Island 20% and 16,8% for Azores.

Is it easy to set up a business?

There are multiple opportunities for South Africans to set up a business in Portugal. The process is relatively simple and is much the same for all international investors.

Portuguese banks make it quite easy to open a bank account for non-residents and foreigners.

Is it easy to set up personal and business bank accounts?

The banking and maintenance fees are also quite low compared to the rest of Europe.

You will need a passport or government-issued travel

document, a NIF number, a Portuguese phone number, proof of address from your country of residence, and proof of income/payslip.
